The functions of the Data Controller, in accordance with the Directive of the Minister of Economic Development adopted on 28th January 2020, are exercised by the Head of the Department for digital, connectivity and new technologies, in relation to competence profiles.

Data processing is implemented in compliance with lawful requirements referred to in art. 6 of the EU Regulation 2016/679 and is carried out exclusively within the rules and for the specific purposes provided by the relevant regulation, complying, in every phase of the processing, with the principles of lawfulness, correctness, integrity and privacy, enshrined in art. 5 of the EU Regulation.

The Data Controller guarantees that access to information is allowed exclusively to authorized Persons for the processing of data (art. 29 and 4, n. 10, of the EU Regulation and art. 2-quaterdecies of the Code), without prejudice to liability arising from unlawful use of the information and provides for, under its own responsibility and within the framework of its organizational structure, giving instructions to the staff in charge of the processing that, expressly designated, operate under his/her authority as authorized Persons.

In accordance with art. 5, par. 1, let. e) of the EU Regulation, acquired data are stored for the time established by the current legislation for administrative purposes and, in any case, only for the time strictly necessary for the fulfilment of the purpose for which the data are processed.
